# DATA RETENTION PERIOD

The data provided, by completing the email with Your request, will be processed by the Company to guarantee the civil access as specified in Legislative Decree 33/2013.

Execution of the contract involving the data subject as regards the request.

Legal obligations as regards the exercise of the right to access pursuant to Legislative Decree 33/2013.

The data will be retained for a 5-year period since the date of the request

Once the above retention periods have expired, the Data will be destroyed, erased or made anonymous, compatibly with the technical erasure and backup procedures.



#### DATA PROVISION COMPULSORINESS

The provision of data for the aforementioned purposes is compulsory to guarantee the information requested and the fulfilment of legal obligations; therefore, if You not provide Your data, the Company will not be able to process Your request.



## **DATA RECIPIENTS**

Personal data may be communicated to parties acting as data controllers (such as supervisory bodies and authorities and public organisations authorised to request data) or processed on behalf of the Company by parties appointed as data processors, who are provided with suitable operating instructions.



#### PARTIES AUTHORISED TO PROCESS DATA

Data may be processed by employees in company departments who are responsible for carrying out the activities outlined above and have been authorised to process the data and have received suitable operating instructions.



### PERSONAL DATA TRANSFERS OUTSIDE THE EU

The data may be transferred to non-EU countries, in particular to:

- a) Non-EU countries "whose data protection level is deemed adequate by the European Commission in accordance with article 45 of the GDPR"
- b) Non-EU countries "after signing standard contractual clauses adopted/approved by the European Commission in accordance with article 46, clause 2, letters c) and d)"

## DATA SUBJECTS' RIGHT'S - COMPLAINT TO THE SUPERVISORY BODY

By contacting the Company via e-mail sent to <u>privacy@sacbo.it</u> data subjects can ask the controller for access to personal data, or the correction or deletion of personal data, and also have the right to restrict processing of the data in the cases set out in article 18 GDPR, and object to processing in the case of legitimate interests of the controller.

Furthermore, in the case where processing is based on consent or a contract and carried out with automated tools, data subjects have the right to receive the personal data in a structured, commonly used and machine-readable format, and to transmit the data to another data controller without obstruction.

Data subjects have the right to lodge a complaint to the competent Supervisory Authority in the member state where they are resident or where they work, or the member state where the alleged breach took place.
