 PROVISION OF PERSONAL DATA
<p>The provision of data is optional but necessary for the conclusion and continuation of the contract; the refusal to provide the aforementioned data does not allow, therefore, to use the services.</p>

 AUTHORIZED SUBJECTS TO THE PROCESSING
<p>Data may be processed by employees of the corporate functions responsible for the pursuit of the purposes, who have been authorized to process and who have been received adequate operating instructions.</p>

 DATA RECIPIENTS
<p>The data may be processed by external parties operating as Data Controllers such as, by way of example, Supervisory and Control Authorities and Bodies and in general public or private subjects, entitled to request the data.</p> <p>The data may also be processed, on behalf of the Company, by external parties designated as Data Controller, who are given adequate operating instructions. These subjects are essentially included in the following categories:</p> <ul style="list-style-type: none"> <li>a. companies that offer e-mail sending services;</li> <li>b. companies that offer website maintenance services.</li> </ul>

 RIGHTS OF THE DATA SUBJECT AND RIGHT TO LODGE A COMPLAINT WITH A SUPERVISORY AUTHORITY
<p>By contacting the Company by e-mail at <a href="mailto:privacy@sacbo.it">privacy@sacbo.it</a>, have the right to ask the Data Controller for access to data concerning themselves, the right to ask for erasure, rectification of inaccurate data, integration of incomplete data, restriction of the data processing as per art. 18 GDPR, as well as opposition to processing, for reasons related to their particular situation, in the hypothesis of legitimate interest of the Data Controller.</p> <p>Furthermore, if the data processing is based on consent or on a contract, and it is processed with automated tools, data subjects shall have the right to receive their personal data in a structured, commonly used and machine-readable format, as well as, if technically possible, have the right to transmit those data to another Controller without hindrance from the Controller to which the personal data have been provided.</p> <p>Data subjects have the right to lodge a complaint to the competent Supervisory Authority in the European State in which they reside habitually or work, or the State in which the alleged data breach has occurred.</p>
