

Cookie Policy

Information Note

The information note on the use of cookies on the web domain milanbergamoairport.it complies with the provision entitled "Simplified Arrangements to Provide Information and Obtain Consent Regarding Cookies" issued on May 8, 2014 by the Italian Data Protection Authority.

This policy aims to describe how cookies are used on the website <http://www.milanbergamoairport.it> and how the processing of personal data relating to the use of these cookies is compliant with current legislation.

What are cookies?

A cookie is a small text file that a website saves on your computer, tablet or mobile device when you visit the site.

It enables the website to remember your actions and preferences (such as login, language, font size and other display preferences) over a period of time, so you don't have to keep re-entering them whenever you come back to the site or browse from one page to another.

While navigating on the site the user may also receive cookies from other websites ("third-party" cookies), such as, for example, specific links to other pages, maps, images, sounds.

Types of cookies:

1. Technical cookies
2. Profiling cookies

1. Technical cookies

Technical cookies are required for the website operation and delivery of the services offered. In the absence of technical cookies, certain functions of the site may be unavailable. Technical cookies can be divided into:

- Navigation or session cookies, which guarantee normal navigation and use of the site (allowing, for example, to of service offered by the Bergamo-Orio al Serio airport website);
- Analytics cookies, designed to gather information in aggregated form for statistical purposes (concerning, for example, the number of users and their navigation behaviour on the website);
- Personalisation cookies that improve the service by personalising the user's navigation experience according to selectable criteria (e.g. preferred language, products of interest etc.)

2. Profiling cookies

Profiling cookies are used to create a profile for users navigating on the website and monitor their navigation behaviour in order to transmit advertising messages for direct marketing purposes. Because of the particular invasiveness that such devices may have in the private sphere of Users, the European and Italian legislation requires that the User must be adequately informed about the use of cookies, in order to express his consent.

Cookies used on the <http://www.milanbergamoairport.it> domain are not used for User profiling activities.

For statistical purposes, a third-party cookie is used: Google in the services of: Google Analytics, Google Tag Manager. SACBO spa is not the controller of these tools; therefore please refer to the information note provided by Google at the following link: <http://www.google.it/policies/privacy/partners/>

How to disable cookies

Most browsers (Internet Explorer, Firefox, Chrome, Safari, etc.) are set up to accept cookies, allowing you to control and/or disable cookies through browser settings.

Certain functions of the website may be unavailable or limited if you disable technical cookies.

Cookies can be easily disabled by accessing the options or preferences of the browser. You can also block the third-party cookies only. Usually, these options will only take effect for that specific browser and on that specific device, unless there are options to unify preferences on different devices.

Specific instructions can be found in the settings or help page of the browser.
