The data subjects, who prefers to be contacted for the aforementioned purpose exclusively through traditional methods, can express their opposition only to the receipt of communications through automated methods.</p> <p>Data subjects have the right to lodge a complaint to the competent Supervisory Authority in the member state where they are resident or where they work, or the member state where the alleged breach took place.</p>
