|  | <b>DATA SUBJECTS' RIGHTS - COMPLAINT TO THE SUPERVISORY BODY</b><br>By contacting the Company via e-mail sent to <a href="mailto:privacy@sacbo.it">privacy@sacbo.it</a> data subjects can ask the controller for access to personal data, or the correction or deletion of personal data, and also have the right to restrict processing of the data in the cases set out in article 18 GDPR, and object to processing in the case of legitimate interests of the controller.<br>Furthermore, in the case where processing is based on consent or a contract and carried out with automated tools, data subjects have the right to receive the personal data in a structured, commonly used and machine-readable format, and to transmit the data to another data controller without obstruction. |

Data subjects have the right to lodge a complaint to the competent Supervisory Authority in the member state where they are resident or where they work, or the member state where the alleged breach took place.
